BREXIT - THE LATEST INFORMATION

THE EUROPEAN COUNCIL HAVE AGREED WITH THE UNITED KINGDOM AN EXTENSION OF THE DATE THE UK IS DUE TO LEAVE THE EU. THIS IS A SUMMARY OF WHAT THIS MEANS IN SIMPLE TERMS

- A Brexit extension, only as long as required but up to a maximum extension of 31 October, to allow for the ratification of the Withdrawal Agreement in the UK Parliament.
- If the UK does not leave the EU by 1 June, the UK will be required to hold elections to the European Parliament.
- The European Council reiterates there can be no reopening of the Withdrawal Agreement negotiations.

EU SETTLEMENT SCHEME – THE LATEST

The EU settlement Scheme (EUSS) for EEA nationals and their family members in the UK who want to continue to live, work or study here after Brexit is now fully open for all applicants. Applications can also be made from outside the UK.
